


朱晓明院长和 刘吉名誉院长拜访 中国上市公司协会及 校友企业 Presidents Visit CAPCO and CEIBS Alumni Enterprises







月7日至8日,中欧国际工商学院院长朱晓明教授与中欧教育发展 基金会理事长、名誉院长刘吉教授在北京拜访了中国上市公司协 会和校友企业中坤集团及中国航空技术国际控股有限公司。

3月7日,两位院长首先来到中国上市公司协会拜会协会会长、我 院董事陈清泰先生。陈清泰会长对两位院长的到访表示欢迎,并介绍了 中国上市公司协会的工作情况。会谈中,朱晓明院长回顾了中欧在过去 一年中所取得的成绩,并介绍了学院未来的发展规划。陈清泰会长表 示,上市公司协会作为一个上市公司的交流平台,可与中欧在教学研究 的诸多方面开展合作。刘吉院长则建议双方优势互补、强强联合,在上 市公司治理等多方面进行学术研究合作,为中国上市企业的发展培养更 多专业人才。据悉,学院将尽快在企业调研、案例研究、高层经理培训 等方面与协会启动洽谈合作。

随后,两位院长一同前往中坤集团,在集团董事长黄怒波(EMBA 1996)校友的陪同下兴致勃勃地参观了公司总部。黄怒波校友向两位院 长介绍了中坤的未来发展和新项目,并再次表达了继续支持学院办学的 意愿。两位院长深深感谢黄怒波校友对学院的捐赠,并表示学院将不遗 余力地帮助校友企业, 共建院企互助共赢的发展模式。

3月8日,两位院长来到中航国际拜访,受到了总裁吴光权(CEO 2003)校友的热烈欢迎。吴光权校友向两位院长介绍了集团的发展历史 及多元化的业务, 并以一段感人的影像资料介绍了集团在全球化发展中 与赞比亚、肯尼亚等非洲国家互惠互利、合作共赢的典型案例。朱晓明 院长表示,多年来中航国际与中欧保持着良好的合作,不仅选送众多高 管参加学院各项课程的学习,更以财务投入的方式支持学院的各项研究 课题。刘吉院长也表示,中航国际的国际化经验和案例令人耳目一新, 学院将发挥教研所长,帮助公司总结研究并推广经验。

uring a Beijing trip from March 7 to 8, CEIBS Executive President Prof Zhu Xiaoming and Honorary President and Director of CEIBS Education Foundation Liu Ji visited China Association for Public Companies (CAPCO) and two CEIBS alumni enterprises, Zhongkun Group and AVIC International.

On March 7 Chen Qingtai, CAPCO Chairman and CEIBS board member, welcomed the school officials to the Association. Both sides provided updates on their work and explored avenues for increased collaboration. Chen noted that, as a communication platform for public companies, there were endless possibilities in terms of how CAPCO could collaborate with CEIBS in teaching and research. Liu Ji added that this mutually beneficial cooperation would foster more professional talent for China's public companies. Potential areas of cooperation between CEIBS and CAPCO include case studies, executive education, etc.

The next stop was a visit to Zhongkun Group's headquarters where Chairman Huang Nubo (EMBA 1996) again expressed his willingness to continue investing in CEIBS' growth and development. 

### CEIBS Launches Research Centre on Globalization of Chinese Firms



月18日,中欧国际工商学院 中国企业全球化研究中心成立 仪式在中欧上海校园举行。作 为中欧首个由多学科教授联合组建的 研究中心, 其汇聚了来自人力资源、 营销、管理、金融和战略等学科的顶 尖师资。该研究中心由飞利浦人力资 源管理教席教授杨国安担任学术主 任,由营销学教授王高担任联席学术 主任, 聘请了副教务长、拜耳领导力 教席教授忻榕, 金融学和会计学系系 主任、法国凯辉会计学教席教授丁远 以及战略学副教授陈威如组建学术委 员会,并将招募研究人员组建专业团 队。

中心将从全球战略、收购兼并、 治理架构、人力资源、公司财务、市 场营销以及地域文化等多方面切入, 以多角度的方式研究中国企业全球化 课题,帮助中国企业克服来自国内外 的诸多挑战,成为真正具备全球视 野、创新意识和全能驾驭复杂全球管 理架构的跨国企业。

作为产学研结合的典范, 研究 中心邀请了五家全球化发展卓越、最 具代表性的校友企业成立公司顾问委 员会,推动实践与研究强强联合。四 维一约翰逊股份有限公司、中国航空 技术国际控股有限公司、春和集团、 TCL集团和金昇集团将在未来三年内 共同出资1000余万元,支持中心的学 术研究并参与学习及知识传播。据介 绍,随着研究中心今后的课题研究及 教学发展,中心还将逐步考虑吸收更 多优秀的全球化中国企业作为理事单 位。

学院院长朱晓明教授、副院长 兼教务长苏理达(Hellmut Schütte) 教授、副院长兼中方教务长张维炯教 授、研究中心教授代表以及校友企业 代表——四维—约翰逊集团董事长王 埏(EMBA 2000)校友、春和集团董 事长梁小雷(CEO 2004)校友和中航 国际集团总裁吴光权(CEO 2003)校 友等出席了研究中心成立仪式。

EIBS announced the launch of the Research Centre on Globalization of Chinese firms (RCGCF) and hosted the Centre's

first roundtable on February 18. The RCGCF was established with the aim of contributing to the integration of Chinese companies into foreign markets. As CEIBS Vice President and Co-Dean Prof Zhang Weijiong noted while delivering the welcome address, the RCGCF "will provide support and insight for Chinese companies to go abroad"

The Centre, the brainchild of FD Johnson President Wang Yan (EMBA 2000), aims to foster discussions about globalization in CEIBS' academic environment. In addition to FD Johnson, it has the support of many leading Chinese companies such as Jinsheng Group, Evergreen Holding Group, Chunhe Group, TCL Group and AVIC International. These enterprises will provide financial support and collaborate with CEIBS faculty who are doing research for the Centre. Among these faculty members is RCGCF Director, Philips Chair Professor of HR Management Arthur Yeung who explained - while giving an overview of the project – that the results of the Centre's research "will help many Chinese companies, not only the ones participating in the project".

The launch was also attended by CEIBS Vice President & Dean Hellmut Schütte, directors from various school departments, as well as representatives from the companies that are partnering with CEIBS in the work being conducted by the Centre. It ended with a group photo to commemorate the event, and select participants then engaged in the roundtable talks.
